### I. Introduction:

- 5. Conducting lectures and organizing workshops and conferences.
- 6. Exchange of knowledge and literature.

#### III. Composition:

The collaboration involves two primary groups:

- 1. Regular faculty members and students of the Br. Balasaheb Khardekar College, Vengurla.
- 2. Regular faculty members and students Anandibai Raorane Arts Commerce and Science College, Vaibhavwadi.
- A. Mutual and separate responsibilities of Br Balasaheb Khardekar College Vengurla and Anandibai Raorane Arts Commerce and Science College, Vaibhavwadi.

## B. Faculty Staff and Students:

- 1. Each of the participating institutions is fully responsible financially and operationally for its respective employees.
- 2. The cost of secretarial and clerical personnel, technician, and other scientific support personnel will be borne by the person concerned or employer of such personnel.

## B. Space and Facilities:

- 1. Working space and infrastructure required for the project will be provided by respective Institutions.
- 2. Joint use of each other equipment and facilities as long as such cooperative use does not disturb normal programs of either party.
- 3. Any damage or loss to a property will be borne by the personnel responsible for the employer.

#### C. Ownership of Intellectual Properties:

Collaborative research activities under the MOU, if results in any potential for intellectual property, both organizations shall seek equitable and fair ownership and other property interests.

## D. Amendment and termination of MOU:

- 1. This MOU may be amended or modified by mutual written agreement signed by the representatives of both institutions.
- This MOU will come in force from the academic year 2019-20 for the period of 05 years. This
  MOU shall be renewed after being reviewed and renegotiated sated by both institutions.
- 3. This MOU May be terminated at the will of anyone or both the parties upon prior notice to the other in writing by the representatives of respective Institutes.
