- e) There will not be any financial obligation/charge/ burden on the college due to the activities conducted under MoU.



- f) The college will provide its consultancy and expertise along with infrastructure as a part of collaboration. As the college is empanelled for Social Impact analysis and Third-Party Audit by Government of Maharashtra.
- g) The students will get first hand exposure.
